TERMS OF AGREEMENT

This Membership Agreement (hereafter referred to as the "Agreement") shall commence on _____, between _____ (hereafter referred to as the "the Member") and the Bushido Aikido Apopka Dojo (hereafter referred to as the "Dojo"). Membership shall commence from the date of execution of this Agreement and renew automatically on the first (1st) day of every month.

MEMBERSHIP DUES

Payment for instruction in aikido classes (hereafter referred to as "Membership Dues") are to be paid on a monthly basis as described by the selected fee schedule below and by the following requirements:

- 1) All Membeship Dues will be paid by automatic debit through the dojo's online payment system
- 2) All Membeship Dues will be paid on or before the 3rd of each month
- 3) All Membeship Dues will be paid regardless of the Member's current attendance at the Dojo
- 4) Upon cancellation of membership, the Student agrees to notify the Dojo upon paying one month's Membership Dues. The

Member understands that Membership Dues include regular classes only. Additional events and functions, such as seminars, workshops, and testing fees, are not included in the Membership Dues, as they are paid as needed and are not a requirement to continue membership at the Dojo.

CANCELLATION OF MEMBERSHIP

This non-binding and open-ended Agreement will remain in force until either party (the Member or the Dojo) are notified of the intent to terminate by the other party. Intent to terminate must be submitted in the form of electronic mail (e-mail) or by printed mail. Upon receipt of such intent to terminate, the Student authorizes the Dojo to collect one final installment of Membership Dues as a confirmation of the membership cancellation. *(*ALL Students Must Remain Enrolled)*

LIABILITY WAIVER

I, _____, the undersigned, hereby express my desire to for membership and to participate, hereafter referred to as the "Participating Student" or "Student", in the martial art of aikido as taught at the Bushido Apopka Aikido Dojo (hereafter referred to as the "Dojo" or "Studio".)

A) I understand that the art of aikido is a physical activity that includes exercise, direct bodily contact, and actions that may result in injury.

B) As consideration for acceptance as a member of the Dojo, I (the Student) agree to:

- a. ASSUME FULL RESPONSIBILITY for the Student's safety, and for any injuries they might suffer or inflict on others while participating in any class or event.
- b. DEFEND, INDEMNIFY, SAVE, and HOLD HARMLESS the Dojo, it's employees, staff, instructors, assignees, members, servants, and agents, from any and all demands and damages, losses, liabilities, costs and expense for any reason now and in the future.

C) I grant the Dojo permission to use the Student's name and image(s) for the purpose of marketing and publicity without restrictions.

D) I acknowledge that this Agreement is governed by the laws of the State of Florida, and that any action involving parties or issues relating to this Agreement must be instituted and prosecuted in the appropriate court sitting in Seminole County, Florida.

E) This Agreement is a legally binding contract. It is intended to provide as broad and inclusive release of liability as is legally possible, but it is not intended to assert any claims that are prohibited by law. If any part of this Agreement is determined to be unenforceable, all other parts shall be given full force.

F) I HAVE READ THIS RELEASE, and understand it to be a complete and total release of all claims that may occur while at the Dojo, while practicing the martial art of aikido or not, and that this release obligates the Student to indemnify the named parties for injury or death of any person and damage to property caused by the Student's actions.
